The Program Director will manage and mentor some of the team's Policy Advisors, Policy Associates, Fellows, and Interns to advance their initiatives. This position will report to the Managing Director of Public Policy.

- Support the development of transmission and electricity markets policies in a supervisory role;
- Conduct analyses of policy and industry trends;

- Produce research insights and written products pertaining to ongoing clean energy legislative, regulatory and innovation activities across the federal government; and
- Track federal clean energy programs, such the RD&D programs at the Department of Energy and U.S. National Laboratories, and make recommendations to improve impact.
