She also served as Assistant Secretary at the U.S. Department of Housing and Urban Development, Senior Advisor in the Office of the Federal Coordinator for Gulf Coast Rebuilding, Deputy Chief of Staff at the Federal Deposit Insurance Corporation, and Deputy Assistant Secretary at the US Department of Education.
